CONCURRENT NOTICE NOTICE TO PUBLIC OF FINDING OF NO SIGNIFICANT IMPACT AND NOTICE TO REQUEST RELEASE OF FUNDS

TO ALL INTERESTED AGENCIES, GROUPS AND PERSONS:

This notice shall satisfy two separate but related procedural requirements for the activities to be undertaken by the County of Venango.

Request for Release of funds:

On or about December 28, 2020, the above-named Grantee will request that the Department of Community and Economic Development (DCED) release funds for the FFY2019 CDBG funds for the following project:

FFY 2019 CDBG Clinton Township Building ABR Project:

Total: \$70,000

The County of Venango proposes to utilize funds from FFY2019 CDBG entitlement to construct a unisex public restroom in the northeast corner of the township building's first floor. Additionally, exterior work will include handicap signage, a new handicap-accessible parking pad with line striping, a paved walkway connecting the parking pad to the building, new automatic push button entry door, new sewage holding tank and plumbing, and a new water line from existing water cistern.

The Township Building is without restroom facilities or building entrances that are readily accessible to the elderly and disabled. Due to this lack of amenities, the building no longer serves as a local polling place. The lack of accessible facilities also prohibits local community-based organizations from utilizing the building.

The Township Building is without restroom facilities or building entrances that are readily accessible to the elderly and disabled. This is preventing use of the building as a polling place or location for other community events. Clinton Township is a rural municipality with an aging population with few meeting locations. The township needs to maintain a location that is accessible to all its residents.

The total CDBG Program funds requested for this project is \$70,000.

FINDING OF NO SIGNIFICANT IMPACT

It has been determined that such Request for Release of Funds will not constitute an action significantly affecting the quality of the human environment and accordingly the above-named Grantee has decided not to prepare an Environmental Impact Statement under the National Environmental Policy Act of 1969 (PL 91-190). The reason for the decision not to prepare an Environmental Impact Statement is as follows:

PUBLIC COMMENT ON FINDINGS

All interested agencies, groups and persons disagreeing with this decision are invited to submit written comments for consideration by the Grantee to the Venango County Regional Planning Commission, 1168 Liberty Street PO Box 831. Such written comments must be received **on or before December 28, 2020**. Comments shall specify which part of the notice they are addressing. All such comments so received will be considered and the Grantee will not request the release of SCP funds or take any administrative action on the above-named projects prior to the date specified in the preceding sentence.

ENVIRONMENTAL CERTIFICATION

Venango County also certifies to DCED that Michael C. Delaney, County Commissioner, consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to Environmental Reviews, decision making and action; and that these responsibilities have been satisfied. DCED's approval of the certification satisfies its responsibilities under the National Environmental Policy Act of 1969 and related laws and authorities, and allows Venango County to use program funds.

OBJECTIONS TO RELEASE OF FUNDS

DCED will accept objections to its release of funds for Venango County's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of Venango County; (b) Venango County has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by DCED; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec.58.76) and shall be addressed to Department of Community and Economic Development, Center for Community Building, 4th Floor, Commonwealth Keystone Building, Harrisburg PA 17120-0225 or emailed to Christine Howe at chrhowe@pa.gov. Potential objectors should contact DCED to verify the actual last day of the objection period.
