ORDER OF COURT

AND NOW, July 25, 2007, effective immediately, the Court hereby adopts the following procedures for filing Motions for Continuances in the Criminal, Civil, Orphans' Court and Juvenile Divisions and the Domestic Relations Section. Said procedures shall also apply to matters scheduled for hearings before a Master, Mediator, and Board of Arbitrators.

- 1) The Motion shall be in writing and shall be docketed in the appropriate office before being transmitted or hand-delivered by the attorney to the Judges' Chambers.
- 2) The Motion shall include the court, caption, term, and number of the case.
- 3) The motion shall state with particularity the grounds for the motion, the facts that support each ground, and the type(s) of relief requested and shall include a proposed Order.
- 4) The motion shall contain the name, telephone and telefax numbers of opposing counsel and a certification from moving counsel on the position of opposing counsel. This Court will not contact opposing

counsel to secure their position on the Motion; it will take no action on the Motion if the position of other counsel is not specified.

- 5) A second or subsequent Motion for Continuance shall state that it is a second or subsequent Motion and shall state whether or not the client of the attorney requesting the continuance agrees to the continuance.
- 6) Counsel shall inform the Court in the Motion to Continue of any dates he or she is unavailable for hearing.
- 7) Moving counsel shall provide a copy of the executed Order of Court to all counsel or parties.
- 8) All Motions for Continuance which are based upon a calendar conflict due to an appearance in another Court must include a copy of the scheduling Order or notice issued by the other Court.

This Order is intended to supplement Pa. R.C.P. 575 and to amend the Administrative Order of this Court dated December 9, 1998.
